# 具有动态不确定性互联大系统的分散自适应控制

摘要: 对一类具有未建模动态结构相似形的严格反馈非线性互联大系统, 提出一种基于神经网络的分散自适应动态 面控制方案. 该方案引入Lyapunov函数来约束未建模动态, 利用神经网络逼近理论分析中所产生的未知非线性连续函 数. 通过Young's不等式和三重求和项的分解, 有效地处理了耦合作用项, 并利用动态面控制技术, 实现了系统的分散控 制. 与现有研究结果相比, 所设计的分散控制律中不含有控制增益下界常数. 通过构造的方法, 利用动态面控制设计中 引入的紧集有效地处理了未建模动态和分析中产生的不确定连续函数. 理论分析证明了闭环控制系统中所有信号半全 局一致终结有界, 且跟踪误差收敛到原点的一个小邻域内. 两个数值算例的仿真结果表明所提控制方案的有效性.

# Decentralized adaptive control for large-scale interconnected systems with dynamic uncertainties

Abstract: We present a decentralized adaptive control scheme based on neural networks and dynamic surface control for a class of interconnected nonlinear large-scale systems in strict-feedback form with similar structure and unmodeled dynamics. In the designed scheme, unmodeled dynamics is described by using the Lyapunov function method, and neural networks are used to approximate the unknown nonlinear continuous functions which are produced in theoretical analysis. The interconnected terms are effectively dealt with by using Young's inequality and decomposition of the threefold summation term, and the decentralized control is realized by utilizing dynamic surface control technique. Compared with the existing results, the designed decentralized control laws do not contain the lower bound of control gain. By the constructing method and the compact set introduced in dynamic surface control design, the unmodeled dynamics and uncertain continuous functions generated in the recursive design are effectively handled. By theoretical analysis, the closed-loop control system is shown to be semi-globally uniformly ultimately bounded, with the tracking error converging to a small neighborhood of the origin. Simulation results of two numerical examples show the effectiveness of the proposed scheme.

Key words: unmodeled dynamics; dynamic surface control; strict-feedback; interconnected system; decentralized adaptive control

## 1 引言(Introduction)

自从后推技术和动态面设计方法在文献[1-2]中 被提出后,这两种方法已经成为非线性控制系统设计 的重要手段,并在各种非线性系统自适应控制器设计 中得到了广泛应用.文献[3]利用后推技术,对一类严 格反馈非线性系统,设计了自适应神经网络控制器. 由于后推设计需要对虚拟控制器反复求导,从而导致 控制器设计越来越复杂.针对上述不足,文献[2]通过 在递推设计中引入一阶滤波器,实现了代数运算代替 微分运算,简化了控制器的设计.基于动态面控制,文 献[4-9]对严格反馈单输入单输出非线性系统提出了 多种控制方案. 文献[4]对具有未知控制增益的严格 反馈系统, 结合最小学习参数、输入状态稳定和小增 益方法, 提出了鲁棒自适应神经网络控制方法. 文献 [3,5,9]分别讨论了具有参数化形式的外界扰动, 具有 周期性外界扰动和具有状态时滞情况下的控制系统 信号的有界性和稳定性问题. 文献[10]利用积分型 Lyapunov函数, 对具有未知死区和不确定扰动的纯反 馈非线性系统, 提出了基于神经网络的动态面自适应 控制.

在实际控制系统中,人们很难建立被控对象的精 确模型,因而存在建模误差,系统模型简化和参数测

量误差也会导致系统具有不确定性,这些不确定性统称为未建模动态.未建模动态和系统的外部扰动都可能对控制系统的稳定性造成不利影响.文献[11–12]中提出引入动态信号和利用Lyapunov函数两种用来处理未建模动态的方法.文献[13]通过Lyapunov函数约束未建模动态,对一类具有不确定性的严格反馈非线性系统,设计了神经网络自适应动态面控制器.文献[14]借助Nussbaum函数,对一类带有未知增益和未建模动态的纯反馈非线性系统,引入动态信号并利用后推技术设计了神经网络自适应控制器.文献[15]对一类具有未建模动态非仿射纯反馈非线性系统,提出了神经网络输出反馈控制方案.

文献[16-17]将文献[11]中提出的动态信号的方法 推广应用到多输入多输出非线性系统. 文献[16]针对 含有未知参数、不确定非线性、外界扰动和未建模动 杰的多种不确定性多输入多输出系统,设计了具有自 适应非线性阻尼项的观测器. 文献[17]提出模糊输出 反馈形式的动态面控制方案. 正如所知道的, 在耦合 大系统中,由于各子系统的状态之间不可避免地存在 耦合作用,因此如何有效地处理耦合作用项,实现大 系统的分散控制是研究耦合大系统控制器设计的关 键技术. 文献[18]对具有耦合作用项和未建模动态的 耦合大系统,提出分散L1自适应控制器设计方案.文 献[19]引入修正的动态信号处理未建模动态,利用自 适应非线性阻尼项来抵消高阶耦合项的影响. 文献 [20]针对多机组电力系统的模型实例设计的自适应模 糊控制方案中每个子系统能够自适应补偿未知的扰 动和互联项. 文献[21]基于动态面设计方法, 对具有严 格反馈形式的耦合非线性系统,设计了神经分散自适 应控制器,其中关于耦合项的假设无需满足匹配条件. 文献[22-23]对系统状态不可测且具有外部扰动和未 知控制增益符号或未知输入死区的MIMO非线性系 统提出了输出反馈模糊跟踪控制方案. 文献[24]采用 滑模控制,利用Nussbaum函数,对含有未知死区和未 知控制增益方向的MIMO非线性系统,设计了自适应 神经跟踪控制器. 文献[25]利用控制系数矩阵的谱半 径放宽了控制系数矩阵非奇异的假设条件,对具有非 对称输入约束的MIMO系统提出了自适应跟踪控制 方案. 文献[22,24-25]中, 第i个子系统的控制器中需 要使用前i个子系统的状态或输入信息,因此是集中控 制. 文献[20-25]的控制方案中都未考虑未建模动态对 系统稳定性的影响. 文献 [26] 讨论了一类耦合大系统 的分散控制问题.

本文在文献[13,26]基础上,对一类具有未建模动 态的结构相似形严格反馈非线性耦合大系统,提出一 种分散自适应神经网络动态面控制策略.与文献[26] 相比较,主要贡献与区别如下:1)本文引入Lyapunov 函数来约束未建模动态,避免了动态信号的使用<sup>[26]</sup>. 所设计的虚拟控制律和控制律中避免了使用控制增 益下界常数<sup>[26]</sup>,并通过重新选取适当的Lyapunov函数,证明了该控制方案的有效性. 2)通过Young's不等式和三重求和项的分解,有效地处理了耦合作用项和动态不确定性,并利用动态面控制技术,实现了系统的分散控制;减少了处理耦合项所产生的需要自适应的未知参数个数,从而减少了控制策略中的估计参数数目.而文献[26]利用多重求和项下标交换规则处理耦合作用项的方法是值得商榷的. 3)自适应律和控制律中包含了神经网络径向基函数向量,充分地利用了 子系统的信息调节参数,并且避免控制律中使用符号函数,有效地抑制了控制律的抖动.

# 2 问题描述及基本假设(Problem statement and basic assumptions)

考虑一类由N个互联不确定非线性子系统组成的 大系统,其第*i*个子系统描述如下:

其中:  $\bar{x}_{ij} = (x_{i1}, x_{i2}, \dots, x_{ij})^{\mathrm{T}} \in \mathbb{R}^{j}, j = 1, 2, \dots, n_{i}, i = 1, 2, \dots, N; x = (\bar{x}_{1n_{1}}^{\mathrm{T}}, \dots, \bar{x}_{Nn_{N}}^{\mathrm{T}})^{\mathrm{T}} \in \mathbb{R}^{\bar{N}}$ 为 包含N个子系统全部状态的向量,  $\bar{N} = \sum_{i=1}^{N} n_{i}; u_{i} \in \mathbb{R}, y_{i} \in \mathbb{R}$ 分别为第i个子系统的输入和输出;  $g_{ij}(\bar{x}_{ij}), f_{ij}(\bar{x}_{ij})$ 为未知光滑函数, 且满足 $f_{ij}(0, \dots, 0) = 0; z_{i} \in \mathbb{R}^{n_{i0}}$ 为不可测状态部分, 又称为未建模动态;  $\Delta_{ij}(t, z_{i}, \bar{x}_{in_{i}})$ 为动态扰动, 且 $\Delta_{ij}(t, z_{i}, \bar{x}_{in_{i}})$ 和 $q_{i}(t, z_{i}, x_{i1})$ 是满足Lipschitz条件的连续函数,  $d_{i}(x, t)$ 是耦合作用项,  $j = 1, 2, \dots, n_{i}, i = 1, 2, \dots, N$ .

控制目标:对第*i*个子系统设计分散自适应控制器*u<sub>i</sub>*,使系统输出*y<sub>i</sub>*跟踪一个给定的期望轨迹*y<sub>id</sub>*,闭环系统全局一致终结有界,跟踪误差收敛到一个小的残差集内.

**假设1** 光滑非线性函数 $g_{ij}(\bar{x}_{ij})$ 符号已知且满 足 $0 < g_{ij0} \leq |g_{ij}(\bar{x}_{ij})| \leq g_{ij1}, g_{ij0}$ 和 $g_{ij1}$ 为未知正常 数. 不失一般性, 假设 $g_{ij}(\bar{x}_{ij}) > 0$ .

注1 本文研究对象的每一个子系统均含有未建模动 态和动态不确定项,而文献[21]不含未建模动态和动态不确 定项. 与文献[17]相比, 本文研究了一类具有未建模动态和耦 合作用项的严格反馈非线性大系统, 而文献[17]中的研究对 象是输出反馈形式.此外,本文通过引入假设4-5有效地处理 了未建模动态,避免了动态信号的引入,从而减少了用于逼近 未知连续函数的神经网络的输入变量个数,而文献[17]通过 引入一种动态信号来消除未建模动态的影响.

# 3 分散神经网络动态面控制器设计(Design of decentralized neural dynamic surface controller)

因此, 闭环控制系统中的所有信号 $s_{ij}, y_{i,j+1}, \tilde{\lambda}_{ig}, \tilde{d}_{ig},$  $\|z_i\|$ 都是一致终结有界的, 从而 $x_{ij}, \alpha_{i,j+1}, \omega_{ij}, u_i$ 也 都是一致终结有界的.

# 5 仿真结果(Simulation results)

在本节中,为了验证所提控制算法的有效性,两个 数值仿真例子被演示.

**例1** 考虑具有未建模动态的小车上双倒立摆 系统<sup>[18,22,30–31]</sup>,其动态方程描述如下:

仿真结果如图1-4所示. 由图1-2可以看出, 本文提出的自适应控制算法具有较强的鲁棒性和良好的跟踪性能.



**例2** 考虑具有未建模动态的3个倒立摆组成的 耦合系统<sup>[17]</sup>,其动态方程描述如下:

其中:  $x_{i1}$ 是第i个摆的角度, g是重力加速度,  $M_i$ 是第 i个杆的质量, l是每一个杆的长度, a是支点到杆的重 力中心的距离,  $k_1 \pi k_2$ 是弹簧的弹性系数,  $u_i$ 表示第i个子系统的输入. 仿真中, 类似于文献[17]的讨论, 取 未 建 模 动态为  $q_i(z_i, y_i) = -z_i + y_i^2$ , 动态干扰为  $\Delta_{12}(z_1, y_1, t) = z_1^2$ ,  $\Delta_{22}(z_2, y_2, t) = z_2^2 \sin t$ ,  $\Delta_{32}(z_3, y_3, t) = z_3^2 \cos t$ , 耦合作用项为

**注 2** 例1中耦合作用项上界多项式的阶次P = 1, 而 例2中耦合作用项上界多项式的阶次P = 0. 仿真结果表明本 文所提控制算法对文献[17]中的3例立摆系统是有效的. 从 图5和文献[17]中的图5可知,本文获得的输出进入稳态的时 间比文献[17]短.

## 6 结论(Conclusions)

本文研究了一类具有未建模动态和动态扰动的

严格反馈非线性耦合大系统的分散自适应控制问题. 采用Lyapunov函数来描述未建模动态的特性,利用 Young's不等式和三重求和项的分解,有效地处理了耦 合作用项,进一步,借助于动态面控制设计方法的特 点,设计了分散自适应神经网络控制器.与现有结果 相比,所设计的分散控制律中不含有控制增益下界常 数,自适应律和控制律中包含了神经网络径向基函数 向量,充分地利用了子系统的信息调节参数,并且避 免控制律中使用符号函数,有效地抑制了控制信号的 抖动.通过理论分析,证明了闭环控制系统中的所有 信号一致终结有界,且跟踪误差收敛到原点的一个小 邻域内.
